The Committee proceeded with a page by page discussion on the Budget Estimates of Provincial Revenue and Expenditure, 2020 for the Department of Premier.

The Chairperson thanked the Department for its preparation and responses to the questions raised by the Committee members.

- 6.2.1 A breakdown of the R100 000 that was allocated and funded to the SPCA;
- 6.2.2 A breakdown of the amounts that the Department paid for advertising to the organisations listed under table 1.4 on page 37.
- 6.2.3. A copy of the correspondence relating to the District Development Model to the municipalities.
- 6.2.4 A copy of the agreement between the Department and the Hospital of Hope. The Department should include a report stating when the Clause would start to apply where the rental would be charged at 12.8 million per month.
- 6.2.5 A report of the funds used for the Communications campaign and names of the service providers used; this should include the strategy that was used for the rural areas.
- 6.2.6 A report on the setup of the boardrooms that is used to assist the COVID-19 Contact Centre; the report should include the number of boardrooms, location and the equipment used for these boardrooms.
