GUIDELINE FOR MUNICIPAL COUNCILLORS ACTING IN THEIR CAPACITY AS COMMISSIONERS OF OATHS

1. PURPOSE

To provide municipalities with a Guideline for Municipal Councillors acting in their capacity as Commissioners of Oaths. Section 6 of the Justice of Peace and Commissioners of Oaths, 1963, allows the Minister, by notice in the Gazette, to designate the holder of any office as commissioner of oaths. Hence, the Minister has, in Item 5(a) (ii) (aa) of the Designation of Commissioners of Oaths Government Notice 903 in GG 19033, dated 10 July 1998, designated a council member of a municipality as an ex officio commissioner of oaths.

2. BACKGROUND

On 13 September 2018, Swartland Municipality requested the Department to develop a Policy on Councillors acting as Commissioners of Oaths. The Department developed the Policy and the draft Policy was circulated to municipalities for comment on 24 September 2018. Comments were received from municipalities and one of the comments proposed that the draft Policy must rather be a guideline.

The Draft Policy was subsequently forwarded to Legal Services for vetting, incorporating the comments received from municipalities. It is advised that Legal Services agreed with the proposal that the document must be a guideline.

3. CONCLUSION

Herewith attached, a Guideline for Municipal Councillors acting in their capacity as Commissioners of Oaths, to assist municipalities and councillors. This is a Guideline and municipalities can implement it with or without amendments. Municipalities will be contacted for training and awareness with regard to the Guideline.
