11. Mr D America to ask Mr R D Mackenzie, Minister of Mobility:

With regard to the recent taxi strike that turned violent:

What is the preliminary cost estimate to repair or replace public transportation vehicles, such as (a) Golden Arrow buses, (b) MyCiti buses, (c) minibus taxis and (d) any other vehicle for any other form of transportation?

Reply:

According to the information received by Golden Arrow Bus Services (GABS) and the City of Cape Town, the following can be reported:

- (a) During the minibus taxi stay away nine GABS buses were totally gutted (replacement value of R2,9m per bus). Damages were also suffered relating to windows and bus bodies of approximately 200 busses. GABS is in the process of finalising calculations regarding the vandalism repair cost of close to 200 buses as well as the nine burnt out busses.
- (b) MyCiTi Buses there were no buses burnt or buses requiring replacement, however the below buses succumbed to multiple stoning incidents resulting in the estimated damages below:
