Actions taken by the Department and municipalities	What support is provided to municipalities dealing with invasions
The matter of unlawful occupation has been escalated to Legal Services following the court order obtained on 23 March 2019. Demolition of derelict structures is initiated, but was halted due to interdict from the unlawful occupiers in November 2022. An eviction order was obtained 20 July 2022; and unlawful occupiers who were conducting business were evicted. However, as there is no available property and funding for a transitional residential area, unlawful occupation of residential use continues. Housing protest resulted in a land invasion on the sites earmarked for schools. Many engaments with the community were held resulting in the land invasion being stopped and the school construction commenced.	
Encroaching invaders are impacting the road access to the site but the construction of the schools is proceeding. Eviction of the encrcoaching invaders will be undertaken. The land invasion spilled over from the adjacent City of Cape Town site over the cadastral boundaries of the WCG owned site. The occupants of the structures were fenced out of the site to prevent the loss of the whole site which is ear-marked for the construction of the new Helderg Hospital. The matter has been nanded over to Legal Services and Counsel has been appointed for the eviction. Once an eviction order has been granted, the fence will be moved to the cadastral boundaries of the WCG owned site. Active engagements are undertaken with the Ward Councillor to prevent further invasions and risks to the site. The Farm house on property burned down, families living in the house were given material by City of Cape fown Disaster Management to build temporary structures. These structures were built on Erf 308. An eviction application was sought through Legal Services for the eviction of these persons. A static security service was placed on site to monitor and prevent further unlawful occupation of property. Court proceedings through Legal Services resulted in Interdict Order with vacation of persons by 8 February 2022. Eviction order obtained for the vacation of persons on or by 30 June 2022. Matter was tabled at CoCT ALIU War Room meeting and requested assistance for eviction operation. On 20 July 2022 the Sheriff actioned the eviction of persons and belongings from the site and animals were removed by the SPCA. Derelict structures and rubble were removed from the property. A Security service provider was appointed to prevent further invasions. DTPW implemented a security presence in 2019 to address issues such as Sand Mining, theft and land encroachment. On the 5 May 2021 an incident occurred which involved a group of protestors who were attempting to erect structures and burn tyres, claiming that the land would be allocated to them for development. Law Enforcement, SAPS and a Tactical team was engaged to dismantle structures and prevent further damage to existing infrastructure. Legal services were consulted, resulting in an interdict to prevent further unlawful activities on the property. DOI engaged with Swartland Municipality regarding subdivision and planning of area. The Department escalated the matter to Legal Services and erected "no trespassing signs" at prominent points on property. Western Cape Nature Reserve Board obtained a court order in respect of the nvasion of the property. Identified relocation areas within the reserve, outside of the flood zone for voluntary relocation by unlawful occupants. The Department investigated the notification of encroachment invasion received. Case number: CAS 26/08/2020 was opened at local the Mfuleni SAPS station and afforded to CoCT ALIU for assistance in removal of structures initially removed on 04 August 2020. the following morning new structures were erected and a new case was opened 19/08/2020 as law enforcement would break down structures nowever did not have enough manpower and SAPS refused to assist in the absence of a court order. 20 August 2020 an operation by number of law enforcement and contracted entities was conducted nclusive of property and ten unlawful structures were demolished. An instance of further unlawful occupation occurred whereby an unknown person parked a caravan on the property for the purposes of habitation, however the Department along with assistance of the City of Cape Town ALIU was able to emove the caravan and person. A fencing project is currently in progress at the property to enclose the vacant portion of the property. The City of Cape Town has fenced off the occupied portion of the property. Structures were erected on the property to accommodate the occupants whom agreed to alternative accommodation, except one occupant whom refused as the dwellings were smaller than her makeshift structure. The Department is fencing the remaining portion of the site on which the CDC will be constructed to prevent further land invasions.	DOI arranged with the City the relocation of the illegal occupants to the eastern com of the site. City of Cape Town provided emergency building material for the construction of informal dwellings in a controlled manner. One family did not agree to the relocation and DOI is following a legal process for eviction. The CDC is still in a planning phase ar the plans have not been affected or delayed.
