- (3) whether the warrants of arrest for the suspects are for those same individuals from Lesotho who were initially questioned by SAPS; if so,
- (4) whether SAPS has requested assistance from the Lesotho police for locating the suspects; if not, why not; if so, what are the relevant details;

- (5) whether the CCTV footage of the suspects using the missing person's bank card has been lost; if so, what are the reasons;
- (6) whether any disciplinary action has been taken against anybody regarding the missing footage; if not, why not; if so, what are the relevant details;
- (7) what is the status of the investigation into this matter, two years after it was reported?

- (2) whether there has been an increase in the prevalence of unlicensed and/or illegal firearms; if so, what are the reasons for the increase in prevalence of unlicensed and/or illegal firearms?

- (2) whether the (a) station commander or (b) cluster commander of the Grabouw police station has changed between January 2010 and January 2016; if so, what are the relevant reasons and details;
- (3) whether the station has been without a permanent station commander for any period since 2008; if so, (a) for how long was an acting station commander appointed, (b) who was designated as the acting station commander and (c) what was the reason for the permanent station commander being absent?
