
The Chairperson submitted the draft Committee Report, which was considered and adopted.

- 6.2 A list of all vacancies in funded posts, and where there were posts vacant for six months or more, (i) when the posts became vacant, (ii) when the posts were advertised, (iii) what the results of the advertisements were, (iv) when the head-hunting exercises started, and (v) when the positions were filled.
