4. Resolutions/Actions



The briefing should include the top 10 goods procured across departments in the retail space, the top 10 services procured across departments, and the top 10 costs related to building infrastructure expenditure, (particularly in the construction sector and the leasing of office space), and how these costs relate to current market values.

4.2 The Committee also REQUESTED that the Provincial Treasury provide the Committee with the matrix of issues presented to National Treasury, and a report on the engagement that took place between the two departments on 4 and 5 February 2020, particularly in terms of any potential amendments to regulations, legislation and other red tape blockages that were discussed.
