1. Welcome and attendance

The Chairperson welcomed the Committee Members, the Minister, members of the public and the officials from the Provincial Treasury.

2. Consideration of Vote 3: Provincial Treasury in the Schedule to the Western Cape Appropriation Bill [B 3-2020]

The Minister and the Head of Department, Mr D Savage, gave a brief overview of the appropriation of funds for the Provincial Treasury as outlined in the Western Cape Appropriation Bill [B 3-2020].

The Committee proceeded with a discussion on the 2020 Budget Estimates of Provincial Revenue and Expenditure for the Provincial Treasury.

The Committee deliberated and engaged the Department on the budget.

The Chairperson thanked the Department for its preparation and responses to the questions raised by the Committee members.

The Chairperson opened the meeting for submissions from the public, however, no comments or submissions were received.

At the conclusion of the meeting, the Committee deliberated on the Vote as follows:

The Standing Committee on Finance, Economic Opportunities and Tourism, having deliberated on the subject of Vote 3: Provincial Treasury, in the Schedule to the Western Cape Appropriation Bill [B 3–2020], referred to the Committee in terms of Standing Rule 188, reports that it supports the Vote.

In accordance with Standing Rule 90, the African National Congress expressed its right to reserve its view for the House.

3. Resolutions/Actions

- 3.1 The Committee RESOLVED to request that Provincial Treasury brief the Committee on the new Grant Framework, once the review is completed at the end of August 2020.
- 3.2 The Committee REQUESTED that the Provincial Treasury provide the Committee with a list of land to be released for spatial planning (of which R56 million was allocated by the Provincial Treasury), and what this land would be used for.
