ACT

To repeal the Western Cape Nineteenth Gambling and Racing Amendment Act, 2021; and to provide for matters incidental thereto.

BE IT ENACTED by the Provincial Parliament of the Western Cape, as follows:—

Repeal of Act 3 of 2021

1. The Western Cape Nineteenth Gambling and Racing Amendment Act, 2021, is repealed. 5

Short title

2. This Act is called the Western Cape Nineteenth Gambling and Racing Amendment Act Repeal Act, 2023.
