Regarding the infestations of alien vegetation, particularly pines, next to the Gobos River, a few kilometres upstream from Greyton:

(a) To what extent are these infestations occurring on land under the management of CapeNature, (b) how severe are these infestations and (c) where do these trees appear on the ranked priority list for alien clearing?

- (1) (a) What funds has her Department allocated to Targeted Universal Testing for TB (TUTT) in (i) 2023, (ii) 2024, (iii) 2025 and (iv) 2026 and (b) in which districts will TUTT be rolled out;
- (2) whether the tests that are used for TUTT are able to detect asymptomatic cases of TB; if so, what are the relevant details?

- (2) whether there are any existing facilities in this category scheduled to be expanded or upgraded in 2023/24; if so, what are the relevant details?

- (1) (a) How many stoma patients have been treated at each of her Department's hospitals in the last 12 months, (b) what are the clinical guidelines relating to ostomy care at her Department's facilities and (c)(i) how many ostomy bags a month are given to each patient and (ii) what are the reasons for this number of bags being given to ostomates in a month;
- (2) whether any of her Department's facilities experienced shortages of ostomy bags the last 12 months; if so, what are the relevant details;
- (3) whether there have there been any complaints from patients about pouching system leaks; if so, what is being done to address this;
- (4) (a) what supportive products are available in line with clinical guidelines, (b) how many qualified stoma nurses are there at her Department's facilities and (c) what is being done to ensure that patients can continue with their daily lives in the event of a ostomy bag shortage?
