1. Mr G Brinkhuis to ask Mr J J Londt, Minister of Social Development:

- (1) What (a) support does his Department offer to the existing safe homes for abused women, (b) is the total number of safe homes in the province and (c) is the status of each safe house:
- (2) whether the safe homes are able to accommodate the increasing number of abused women; if not, why not;
- (3) whether any skills programmes are offered at these safe homes; if so, what are the relevant details?

2. Mr B N Herron to ask Mr A R Winde, Premier:

With reference to his address at the opening of the Western Cape Provincial Parliament in which he said that LEAP officers had made more than 34 000 arrests since the launch of the programme:

- (1) What is the (a) number of arrests, by crime category, for each of the LEAP priority areas and (b) impact of LEAP officers on communities where the murder rate has increased over the past four years since LEAP officers had been deployed in those areas;
- (2) seeing that the Western Cape Safety Plan states that "addressing spatial inequality and the lack of social cohesion in our communities are further important dimensions of the Western Cape Safety Plan", how has the Western Cape Government addressed (a) spatial inequality and (b) social cohesion;
- (3) in terms of the ministerial responsibilities to address "safety priorities", as set out in Chapter 7 of the Western Cape Safety Plan, what was achieved to date by each of the Ministers measured against the identified "safety priorities";

- (4) given that the Western Cape Safety Plan's interventions are "knowledge-driven", (a) what work has each department conducted to plan, document and evaluate the various interventions upon which they embark to assess whether the metrics associated with each safety priority are on track towards being met and (b)(i) why, (ii) where and (iii) how;
- (5) whether there is a document with the work in (4) above available; if so, can a copy be made available:
- (6) given the Western Cape Safety Plan's recognition that data and information may "necessitate a change of focus, interventions and/or operational framework" and is "open to adaptation based on results", what data and information have been recorded since the implementation Western Cape Safety Plan;
- (7) whether this data and information have necessitated any change in focus, interventions or operational framework; if so, what are the relevant details;
- (8) whether the Western Cape Safety Plan has been adapted or updated since it was adopted; if not, why not; if so, can a copy be made available?

3. Mr B N Herron to ask Mr A R Winde, Premier:

With reference to the Premier' claim (also included in a speech delivered on 6 April 2024) that "more than 78% of all jobs in South Africa have been created in the Western Cape":

(a) What is the source of the data that informs this claim, (b) what are the details of the data that is the evidence for the statement that 78% of all jobs in South Africa have been created in the Western Cape and (c) in which sectors of the economy were these jobs created?

Whether her Department has any plans to increase the provincial fleet of ambulances during the next five financial years; if not, why not; if so, what are the relevant details?

Regarding the inclusion of Karoo lamb in the South African register as a geographical indicator under the regulations for the protection of geographical indicators and the designation of origin:

What measures are in place to ensure that farmers in the Karoo region of the Western Cape benefit from this designation?

- (2) what is the detailed breakdown of all the recipients who have received load-shedding relief packs in terms of the Load-Shedding Relief Programme (LSRP), including (a) individuals, (b) non-profit organisations (NPOs) and (c) government institutions?

(a) What are the updates regarding the tender for the Renewable Energy Project of the Hessequa Municipality to make the town of Riversdale load-shedding free, (b) what (i) is the value of the contract and (ii) are the specifics of the tender, (c) what (i) is the detailed list of all the service providers who submitted their bids for the tender and (ii) are the respective scores received by each company, (d) to which companies have the tender been awarded and (e)(i) what measures are in place to ensure that SMMEs will benefit from the tender, (ii) when did the project start and what is the (iii) nature and (iv) scope of the project?
