- (2) whether copies of the reports and minutes of these committees can be made available?

- (3) whether a report on the condition of the home is available; if so, can a copy be made available;
- (4) whether she will conduct urgent oversight over the home; if not, why not; if so, what are the relevant details?

- (3) whether a report on the matter was produced; if not, why not; if so, can a copy of it be made available;
- (4) what procedure is in place in his office to ensure that staff members bring complaints received to his attention?

- (2) whether his Department will investigate how this document ended up in the trash; if not, why not; if so, what are the relevant details?
