**1. Ms C Murray to ask Mr R I Allen, Minister of Police Oversight and Community Safety:**

- (1) Whether the SAPS in the Western Cape is aware that notice has been given to the Goodwood SAPS to leave the building that it currently occupies by the end of the month, as the building will be subject to an auction on 31 March 2023; if so, what are the relevant details;
- (2) whether any steps, including securing new premises, have been taken by the SAPS in the Western Cape to ensure that the services offered by the Goodwood SAPS are not disrupted after the end of the month; if not, why not; if so, what are the relevant details;
- (3) whether the SAPS in the province has engaged with the national Department of Public Works to purchase the property that is well known to the community and has been in use for over 50 years; if not, why not; if so, what are the relevant details?

**2. Mr C M Dugmore to ask Mr A R Winde, Premier:**

In the light of recent announcements about the Provincial Energy Plan and taking into account the Municipal Energy Resilience Project (MERP) announced in 2020:

- (1) (a) How much has been spent on consultants or contractors to date and (b)(i) which consultants or contractors were employed and (ii) what was each consultant or contractor paid for services rendered;
- (2) (a)(i) which municipalities benefited from the investment provided in terms of the MERP and (ii) how much megawatt of power was produced by the MERP, (b) what was the cost of each megawatt of energy produced and (c)(i) how many emergency energy packs will be provided in the current financial year and (ii) where will they be distributed?

**3. Mr K Brinkhuis to ask Mr D J Maynier, Minister of Education:**

- (1) Whether he and his Department have plans in place to root out social ills at schools: if not, why not; if so, what are the relevant details;
- (2) whether there has been an increase in the number of incidents of violence and gang-related violence, bullying, gender-based violence, and alcohol and drug peddling in schools; if so, what are the relevant details;
- (3) whether enough psychologists are deployed at the affected schools; if not, why not; if so, what are the relevant details?
